

Eligibility conditions of a Candidate for Assam Panchayat Election '2025 as per Assam Panchayat Act,1994 Section 111 and Rule 62:

- 1) Candidate should attain the age of 21(twenty one) years.
- 2) Candidates want to contest in the Panchayat Election should have a functional sanitary toilet in his/her residence. [Shall furnish affidavit as in Schedule II along with Nomination form as in Rule 62]
- 3) Candidates either by himself or herself or his or her spouse has not violated the legal age of marriage under the Prohibition of Child Marriage Act, 2006
- 4) Candidate should not have more than two living children from a single or multiple partners at the time of filing nomination . Provided that this provision shall not be applicable in respect of those persons, who have more than two children prior to the date of commencement of this Act,(19/03/ 2018). [Shall furnish affidavit as in Schedule II along with Nomination form as in Rule 62]
- 5) Candidate should not be convicted of an offence involving moral turpitude or ordered to give Security for good behaviour from habitual offenders under Section 129 of BNSS'2023, unless a period of four years has lapsed on the date fixed for holding election from the date of his release in case of a sentence or imprisonment and in case of sentence other than imprisonment from the date of conviction.
- 6) Candidate should not been dismissed from Government service; for commission of act involving moral turpitude unless a period of five years has elapsed on the date fixed for holding election from the date of his dismissal.
- 7) Candidate should not have applied to be declared as an uncertified bankrupt or undischarged insolvent.
- 8) Candidate should not been proclaimed a tout under the Legal Practitioners Act.
- 9) Candidate should not hold any service in the office of profit under Government or any educational institution recognised and received grant from the Government, or holds remunerated office under Zilla Parishad, Anchalik Panchayat and Gaon Panchayat or holds any contract under any of the aforesaid bodies or under the Government.
- 10) Candidate should not during the four years immediately preceding the date of election convicted of an offence punishable under Section 135, or clause (a) of sub- section (2) of Section 136 of the Representation of the Peoples Act, 1951 or has been found by competent authority to have resorted to corrupt practice resulting setting aside of his election to any local body or to any legislature in India.
- 11) Candidate should not be a defaulter of payment of any rate, tax cess or fee imposed under the provisions of this Assam Panchyat Act'1994 and the Assam Panchyat (Constitution) Rule'1995 framed thereunder or of any loan of co-operative society,

12) **Education Qualification : Section 111 (2)** [Shall furnish affidavit as in Schedule II along with Nomination form , Rule 62]

A) Gaon Panchayt Member :

Candidate should passed the H.S.L.C. or equivalent examination under any Council or Board recognised by the State or the Central Government

SC / ST and OBC/MOBC :

Candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes (OBC) and More Other Backward Classes (MOBC), the minimum educational qualification shall be studied up to Class X;

B) Anchalik Panchayat / Zilla Parishad Panchayat member:

Candidate should passed the H.S.S.L.C. or equivalent examination under any Council or Board recognised by the State or the Central Government.

SC / ST and OBC/MOBC :

Candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes (OBC) and More Other Backward Classes (MOBC), the minimum educational qualification shall be the H.S.L.C. or equivalent examination passed under any Council or Board recognised by the State or the Central Government.
