

Minutes of the meeting with all Political Parties Sivasagar District on 12th January 2024 at 4:00 pm at chamber of Election officer, Sivasagar.

The gathering, presided over by the Election Officer, Sivasagar, commenced with a warm welcome extended to all attendees. The following key points were discussed during the session:

1. Recognition and appreciation were extended to all recognized political parties for their active involvement in enlisting educated and dynamic youth as Booth Level Agents (BLA), fostering citizen enrollment in the electoral roll.
2. Commendation was expressed for the effective dissemination of information by political parties regarding the schedule of the Special Summary Revision of the Photo Electoral Roll, with the qualifying date set at 01.01.2024.
3. The Election Officer provided all recognized political parties with the list of forms (9, 10, 11, 11a, 11b) on behalf of the Electoral Registration Officer for 95-Demow and 96-Sibsagar LAC, pertaining to claims and objections up to the 12th of January 2024.
4. Political parties were informed that the aforementioned forms' list was accessible not only at Polling Stations but also at the Office of the Assistant Electoral Officer and the Electoral Registration Officer of 95-Demow and 96-Sibsagar LAC.
5. Recognition was given to political parties to scrutinize the list of forms (9, 10, 11, 11a, 11b) and submit objections to the Electoral Registration Officer of 95-Demow and 96-Sibsagar LAC within 7 days from the submission date mentioned in the forms, for necessary action.
6. The Election Officer earnestly urged all political parties to meticulously examine the provided list, ensuring that no eligible electors are unintentionally excluded from enrolling their names in the electoral roll. Their cooperation in this matter is of paramount importance to facilitate an inclusive and thorough electoral registration process.
7. A sincere plea was extended to all recognized political parties for their indispensable cooperation during the Special Summary Revision of the Photo Electoral Roll, with regard to the qualifying date of 01.01.2024. The Election Officer emphasized the significance of collective efforts to ensure the accuracy and completeness of the electoral roll for the upcoming revision.



The meeting was adjourned with a vote of thanks from the chair.


