

**Minutes of the meeting with all Political Parties Sivasagar District on

1. The Election Officer expressed gratitude to all recognized political parties for engaging educated and energetic youth as Booth Level Agents (BLA) to encourage citizens to enroll their names in the electoral roll.
2. Acknowledgment was given to the political parties for disseminating information regarding the schedule of Special Summary Revision of Photo Electoral Roll with respect to the qualifying date of 01.01.2024.
3. The Election Officer provided the list of forms (9, 10, 11, 11a, 11b) to all recognized political parties on behalf of the Electoral Registration Officer for 95-Demow and 96-Sibsagar LAC, pertaining to claims and objections until 21st December 2023.
4. The Election Officer informed the political parties that the aforementioned forms list was also available at Polling Stations, the Office of the Assistant Electoral Officer, and the Electoral Registration Officer of 95-Demow and 96-Sibsagar LAC.
5. It was conveyed to the political parties to scrutinize the list of forms (9, 10, 11, 11a, 11b) and submit objections to the Electoral Registration Officer of 95-Demow and 96-Sibsagar LAC within 7 days from the submission date mentioned in the forms for necessary action.
6. A request was made to all recognized political parties for necessary cooperation during the Special Summary Revision of Photo Electoral Roll with reference to the qualifying date of 01.01.2024.

The meeting was concluded with a vote of thanks from the chair.





