- 5. It was conveyed to the political parties to scrutinize the list of forms (9, 10, 11, 11a, 11b) and submit objections to the Electoral Registration Officer of 95-Demow and 96-Sibsagar LAC within 7 days from the submission date mentioned in the forms for necessary action.
- 6. A request was made to all recognized political parties for necessary cooperation during the Special Summary Revision of Photo Electoral Roll with reference to the qualifying date of 01.01.2024.

The meeting was concluded with a vote of thanks from the chair.
