## Minutes of the meeting with all Political Parties Sivasagar District on 6<sup>th</sup> January 2024 at 4:00 pm at chamber of Election officer, Sivasagar.

The session, presided over by the Election Officer, Sivasagar, commenced with a gracious welcome extended to all participants. The following significant points were thoroughly deliberated during the meeting:

- 1. Acknowledgments were extended to all recognized political parties for actively engaging educated and dynamic youth as Booth Level Agents (BLA) to promote citizen enrollment in the electoral roll.
- 2. Appreciation was expressed for the effective dissemination of information by political parties regarding the schedule of the Special Summary Revision of the Photo Electoral Roll, with the qualifying date set at 01.01.2024.
- 3. The Election Officer provided all recognized political parties with the list of forms (9, 10, 11, 11a, 11b) on behalf of the Electoral Registration Officer for 95-Demow and 96-Sibsagar LAC, pertaining to claims and objections up to the 6<sup>th</sup> of January 2024.
- 4. Political parties were informed that the list of aforementioned forms was available not only at Polling Stations but also at the Office of the Assistant Electoral Officer and the Electoral Registration Officer of 95-Demow and 96-Sibsagar LAC.
- 5. Recognition was given to political parties to meticulously review the list of forms (9, 10, 11, 11a, 11b) and submit objections to the Electoral Registration Officer of 95-Demow and 96-Sibsagar LAC within 7 days from the submission date mentioned in the forms, for necessary action.
- 6. The Election Officer elaborated on the establishment of EVM Demonstrating Centers (EDC) at the Office of the Circle Officer, Sivasagar Revenue Circle, the Office of the Circle Officer, Demow Revenue Circle, and the Election Branch, O/o the District Commissioner, Sivasagar. Additionally, an EVM mobile van was deployed to raise awareness at all polling station locations during public gatherings. Political parties are kindly urged to disseminate this information among their members and encourage them to cast their votes at the awareness centers.
- 7. A heartfelt plea was made to all recognized political parties for their indispensable cooperation during the Special Summary Revision of the Photo Electoral Roll, concerning the qualifying date of 01.01.2024.

The meeting concluded with a vote of thanks from the chair.
