In case none of them are present, then the authority reserves the right to open the quotations on its own. The authority also reserves the right to cancel one or all quotations without mentioning any reason thereof.

Terms & Conditions

- The Bidder shall have to submit the PAN Card, valid Trade License, Relevant documents, Past Experiences and GST returns 2020-21 to 2022-23.
- 2. The successful bidders shall supply the mentioned number of Solar Light to the buyer and install the same in the mining affected rural areas of Sivasagar District.
- 3. The undersigned reserves the right of negotiation with eligible bidder before the finalization of the bid.
- 4. The District Commissioner, Sivasagar reserve the right to reject/accept the quotation without assigning any reason thereof.
- 5. The undersigned reserves the right to reject any or all the bids or accept any bid in total or in parts. The undersigned will award the contract to the successful Bidder (also referred to as the L1 Bidder) whose bid has been determined to be substantially responsive and to be the lowest evaluated bid, further provided that the Bidder is determined to be qualified, as per the Qualification Requirement specified in bidding document to perform the contract satisfactorily.
- 6. The work shall have to be completed within 30 days from the date of award of work or as per written direction of the buyer.
- 7. The bidder shall be finalized & selected for award of contract on the basis of terms and conditions mentioned in the tender.
- 8. The Bidder is required under the contract to deliver the goods to the site. (The storage/handling etc. shall be sole responsibility of the contractor till the Installation and commissioning of the system).

9. It shall be the sole responsibility of the contractor to get verified the quality & quantity of the supplied material at the site of delivery.

10. Firm shall be responsible for proper installation of system with required orientation/ proper sitting of Solar Module. Firm shall depute an authorized representative whenever required at the time of installation & commissioning, inspection etc.

11. The Selected Bidder shall be solely responsible for commencement to completion of the work. It shall be responsible for any loss or damage happens at the work place or during the erection of the system, and shall arrange for repair or compensation at its own cost

12. The Selected Bidder(s) shall warranty that the equipment used in installing the system are new and unused.

13. The replacement of the defective component at the cost of successful Bidder shall be made with similar and/or equivalent make. The replaced component shall not, in any situation, reduce the performance of the system.

14. The Selected Bidder shall commence the replacement/rectification of the defect within seven (7) days from the date of communication of such defect by the buyer.

15. The safety and security of the system shall be sole responsibility of the end user.

16. The warranty period shall be executed by the firm himself or the authorized dealer/ service center of the firm in the Sivasagar District. The warranty will include the total system including battery etc. whatsoever.

17. The supplier shall be responsible to replace free of cost (including transportation and insurance expenses) to the purchaser whole or any part of supply which under normal and proper use become dysfunctional within one month of issue of any such complaint by the purchaser.
