An eligible Citizen, who is going to attain the age of eighteen years on any of the subsequent qualifying dates in the year 2025, that is to say, 1st April, 2025, the 1st July, 2025, or the 1st October, 2025, may also file his or her claim for inclusion of his or her name in the roll, in Form-6, in advance, starting from the date of notice, and the same be considered and decided in the respective quarter of the year with reference to the respective qualifying date.

Every such claim or objection should either be presented in my office or to Assistant Electoral Registration Officers or Booth Level Offcer or sent by post to the address given below so as to reach me not later than the aforesaid date.
