If with reference to the above said qualifying date, there be any claim for the inclusion of a name in the roll or any objection to the inclusion of name or any objection to particulars in any entry, it should be lodged on or before the **28.11.2024** in Form 6, 7 or 8 as may be appropriate.

An eligible Citizen, who is going to attain the age of eighteen years on any of the subsequent qualifying dates in the year 2025, that is to say, 1<sup>st</sup> April, 2025, the 1<sup>st</sup> July, 2025, or the 1<sup>st</sup> October, 2025, may also file his or her claim for inclusion of his or her name in the roll, in Form-6, in advance, starting from the date of notice, and the same be considered and decided in the respective quarter of the year with reference to the respective qualifying date.

Every such claim or objection should either be presented in my office or to **Assistant Electoral Registration Officers or Booth Level Officer** or sent by post to the address given below so as to reach me not later than the aforesaid date.
