SHORT NOTICE INVITING TENDER

The District Disaster Management Authority (DDMA), Sivasagar invites applications from APWD-registered firms, vendors and contractors for shortlisting to undertake repair/restoration works for disaster-affected/damaged institutions, including Schools, Anganwadi Center (AWCs), Hospitals, Panchayat Ghar, Community Halls, etc under SDRF.

Key Details:

- The repairs will be carried out as per SDRF Norms with funding limited to the highest ceiling specified under these norms.
- Estimates for the repair works will be prepared by the respective departments.
- Execution will be implemented under the supervision and guidance of the concerned departments.
- Firms/Vendors will be assigned by DDMA based on the severity of the damage.
- The assignment order of the vendors will be issued under Section 50 of the Disaster Management Act 2005 in the greater public interest, ensuring the continuity of essential institutions for the benefit of society.
- This tender notice is issued only for shortlisting of interested firms/contractors/vendors etc. for 2025-26 flood season only and not guaranteed for works assignment.
- Fund is subjected to availability of Govt fund as and when received from the Govt.
- SDRF Norms is available in the MHA/NDMA/ASDMA website.
- The legal jurisdiction for any dispute will be within Sivasagar district only.

Interested and eligible APWD-registered firms/vendors/contractors are requested to submit their applications to the office of the undersigned during office hours on working days within the stipulated time frame of 21 days w.e.f. 29 / 01 / 2026 to 18 / 02 / 2026 before 4.00 PM with Govt. Court Stamp Rs.8.25/-. GST Registration certificate, PAN Card, APWD Registration Certificate and TAN number in case of partnership firm etc.
